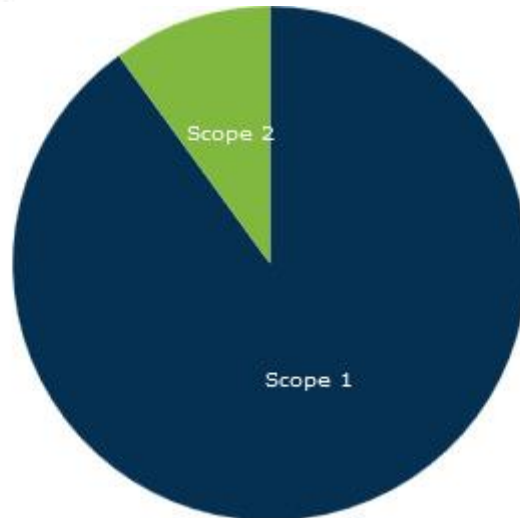
Commitment to achieving Net Zero

Emissions reduction targets

to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 5,000 KGCO₂e by 2027. This is a reduction of 54.44% from the base year of 2021.



Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to a 10%ge reduction against the 2021 baseline and the measures will be in effect when performing the contract

1. Have started replacing company cars with Electric
2. Have adopted LED/PIR lighting controls.
3. Have adopted a policy of recycling waste

In the future we hope to implement further measures such as:

1. Adopting Electric vehicles for Business use
2. Better recycling waste
3. Moving to 100% Renewable Energy suppliers
